PARAMEDICINE PROGRAM INFORMATION

The Paramedicine program offers career training for entry-level personnel, as well as certification/licensure and continuing education courses. Chemeketa offers a diverse, experienced emergency medical services faculty, excellent classroom and laboratory facilities, and outstanding hospital and pre-hospital clinical training sites. Paramedics may be employed by ambulance companies, fire departments, police departments, and industries. There is a great demand for EMTs and paramedics, both locally and nationally. Students working toward a paramedic license will complete approximately 250 hours of hospital clinical experience and 350-600 hours of field internship. Clinical experiences focus on developing the skills, attitudes, and work habits necessary for graduates to be successful in their field.

Mission Statement

Accreditation

Chemeketa Community College offers the Associate of Applied Science in Paramedicine degree and is accredited in Oregon through CCWD (Community College Work Force Development) and the Department of Education, and nationally by the Committee on Accreditation of Educational Programs for the EMS Professions (CoAEMSP) through the Commission on Accreditation of Allied Health Education Programs (CAAHEP).

PROGRAMS OFFERED

Paramedicine Degree

Students take general education courses as well as technical courses devoted to Paramedicine. The paramedic program is limited enrollment for courses EMT296, 297, 298, 280H. The Paramedic program sequence starts in Fall term each year. Students must apply for admission. Information is delivered in several fashions including traditional face-to-face, hybrid, virtual, intense lab practice, scenario training, clinical rotations both hospital and prehospital, and internship, candidates will earn an Associate of Applied Science degree in Emergency Medical Technology. Successful completion qualifies the student to take the State of Oregon and/or National Registry examinations for licensure as a Paramedic.

Paramedic Bridge Certificate

This certificate program is limited enrollment to selected students who have an associate's or bachelor's degree from an accredited college/university, possess a current Oregon EMT License and are actively working in the EMS or Fire career field or are a recent graduate of the Chemeketa Fire Suppression Program. This pathway to a Paramedic License will prepare competent entry-level paramedics in the cognitive (knowledge), psychomotor (skills), and affective (behavior) learning domains through comprehensive education. This process will ensure that each candidate will be prepared for emergency responses and some of the most critical patient encounter with confidence and the ability to perform with an understanding of the current industry expectations.

Credit for Prior Learner and Certification

Chemeketa Brooks offer credit for the experience and classes you have already taken. Credit for prior learning is eligible for our two-year career-technical programs. This program is designed for a person who is currently a Licensed Oregon Paramedic and is seeking to further their professional career through attainment of the AAS degree. Current Paramedic certification may be transcribed as college credits to be applied towards the degree requirements.

PARAMEDIC PROGRAM COURSES

Students who are accepted into the Paramedic Degree Program or Paramedic Bridge Certificate Program will start Fall term with the following sequenced courses. Courses must be completed with a minimum of a “C” grade to remain in the program. See pages 5 and 6 for prerequisites and corequisites information.

ESTIMATED PROGRAM COST

This is an estimated cost of the programs offered. For more complete breakdown of cost, you are welcome to inquire with faculty. Please be aware this is an **estimate** and the actual cost per individual may vary depending on several factors.

- Paramedic Degree Tuition and Fees: \$18,100.00
- Paramedic Bridge Certificate Tuition and Fees: \$12,900.00
- Paramedic textbooks (variable): \$800.00
- Vaccination cost (variable on needs): \$1,110.00
- Uniform/PPE equipment/Physical (variable): \$400.00
- Prerequisite tuition/Books (variable on individual class fees): \$8,400.00

After course completion cost (*fees are not included with the program cost*):

- State licensure: \$290.00
- National Written Exam (Pearson Vue): \$110.00
- National Practical exam (variable on location): \$50.00-\$350.00

ADMISSION PRIORITIZATION

The following will be considered when selecting and prioritizing applicants for the program:

- Completion of admission application packet
- Introductory letter
- Oral interview
- Written essay - applicants with complete packets will be given a set time to write a response and answer a question chosen by EMS faculty.
- EMT level assessment evaluation
- Accumulated points for core courses
- Work history
- Endorsement Letter from EMS Chief/CEO/Chief
- Military Experience (if applicable)—please submit proof to receive points

With acceptance there will be requirements of regular attention to your Chemeketa email for class specifics, meetings, orientations, uniform information, and other opportunities.

PARAMEDIC DEGREE PROGRAM ELIGIBILITY

The Paramedic Degree Program is a limited entry enrollment that starts in Fall term each year. Applicants must meet the following criteria to be considered for a position in the program:

1. Applicant must be licensed as an Oregon EMT and have a current American Heart Association Healthcare Provider certification before the starting date of the Paramedic program.
2. Vaccination requirements will need to be completed prior to the course through our third-party organization. Non-compliance can lead to loss of paramedic course continuation.
3. Applicant must have proof of completion of the prerequisite courses or a reasonable plan of action on how to completion prerequisites before the starting date of the program. (*see page 5*)

PARAMEDIC DEGREE PROGRAM PREREQUISITES AND COREQUISITES

The prerequisites and corequisites for the Paramedic Associate Degree Program are listed below. These classes are available as regular college offerings and will be scheduled by the student at their convenience. If an applicant has not attended college at Chemeketa, please refer to page 7 of this document. The following or equivalent courses must be completed with a minimum of a "C" grade before beginning EMT296. These are considered the "core" courses.

PARAMEDIC BRIDGE CERTIFICATE PROGRAM ELIGIBILITY

The Paramedic Bridge Certificate Program is a limited entry enrollment that starts in Fall term each year. Applicants must meet the following criteria to be considered for a position in the program:

1. Applicant must be licensed as an Oregon EMT and have a current American Heart Association Healthcare Provider certification before the starting date of the Paramedic program.
2. An associate's or bachelor's degree from an accredited college/university.
3. Are actively working in the EMS or Fire career field or are a recent graduate of the Chemeketa Fire Suppression Program.
4. Applicant must have proof of completion of the prerequisite courses or a reasonable plan of action on how to completion prerequisites before or during the program. (see below)

PARAMEDIC BRIDGE CERTIFICATE PREREQUISITES AND COREQUISITES

The prerequisites and corequisites for the Paramedic Bridge Certificate Program are listed below. These classes are available as regular college offerings and will be scheduled by the student at their convenience. If a paramedic applicant has not attended college at Chemeketa, please refer to page 7 of this document. The following or equivalent courses must be completed with a minimum of a "C" grade. These are considered the "core" courses.

To be eligible for this pathway you must have an Associate degree or higher and hold an Oregon EMT license.

APPLYING FOR CHEMEKETA ADMISSION

In order to register for courses, you must first be a Chemeketa Community College Student. Read the below section that best describes your student status.

CURRENT “ACTIVE” CHEMEKETA STUDENTS:

If students do not have any holds on their account that prevent them from registering, please register for class when your Registration Status allows you to register. Registration Status can be viewed in your MyChemeketa account, under Registration. If you have holds on your account and need assistance with registration please contact Enrollment Services (503.399.5001) or Academic Advising (503.399.5120).

First step:

- Apply for admission

Next step: Expect the admission process to take **five to fifteen business days** before you receive notification that you have been accepted as a Chemeketa student. Once accepted you can continue the following steps.

- Claim your Chemeketa student account
- Apply for financial aid
- Complete the new student orientation
 - This is an online video that you access through your MyChemeketa account.
- Complete the placement assessment
 - Estimated processing time: 3-5 business days.
 - Student must place into WR 080 (or higher), and MTH 052 (or higher).
- New student advising
 - Book your appointment as soon as possible. Depending on the time of year students may have to book an appointment several weeks in advance.
